You may complete continuing education equivalent to a Refresher Course if one is not required by your state. You may count education received in lectures, standardized courses (such as ABLS, ACLS, PEPP, PALS, PHTLS, ITLS, etc.), college courses, in service training, case reviews, conferences, etc. Up to 10 hours of the refresher training can be by Distributive Education (online, video or magazine-based).

You must ensure that you cover every topic within the four divisions of the mandatory core content. You must also cover each of the five divisions of the flexible core content; however, you are **not** required to cover each topic.

Mandatory Core Content

Airway, Breathing and Cardiology

8 hours

 - Assess and provide care to a patient experiencing a seizure
 - Assess and provide care to a patient exposed to heat or cold
 - Assess and provide care to a patient experiencing a behavioral problem
 - Assess and provide care to a patient with suspected communicable disease

How to Maintain Your National EMS Certification Recertification Requirements

Paramedic Recertification Requirements

Thank you for your commitment to recertification. NREMT certification gives you recognized credibility across the nation and demonstrates your desire to serve the public with the highest standards. Your certification will continue to serve you well during the course of your EMS career.



Individuals requiring a National Registry card to work must submit recertification materials to the NREMT for processing by February 15 (of the year your certification expires.)

Recertification applications are mailed in November, prior to your expiration date. Returned applications must be postmarked no later than March 31 of the year your certification expires.

Recertification Application Options

Once you've completed the continuing education requirements indicated in this brochure, you can recertify in the following ways:

- 1. Complete the recertification form you will receive in the mail **OR**
- 2. Download and complete a recertification form from the NREMT website *OR*
- **3.** Go to **www.nremt.org**, fill out the on-line recertification form, print it and mail it with signatures.

To Recertify You Need to:

 Be actively working within an emergency medical service, rescue service, or patient health care facility using your ALS skills.

If this is your first recertification renewal and you wish to request Inactive Status, you must have worked at least six months.

- 2. Complete all recertification requirements.
- **3.** Demonstrate continued cognitive competency through continuing education or examination.
- **4.** Submit a complete recertification application prior to March 31 (of the year your certification expires).

Continuing Education Option

Complete a total of 72 hours of education including:

- Completion of an approved DOT National Standard Paramedic Refresher
- Completion of 24 hours of **additional** continuing EMS related education as outlined in this document

• Pay the \$20 (U.S. funds) non-refundable application processing fee at the time of submission of documentation All continuing education hours, to include the refresher, must be completed within the current recertification cycle. Education completed prior to your previous March 31 expiration date will NOT be accepted. If this is your first recertification, only education completed after the date of the initial registration will be accepted. See reverse side for detailed recertification requirements.

- **5.** Maintain skills as verified by your Physician Medical Director. (Requires signature on your recertification application validating competency of skills).
- **6.** Obtain CPR certification at the appropriate level current to March 31.

Exam Option

The recertification by examination option enables you to demonstrate continued cognitive competence without requiring you to document your continuing education.

- Establish an account on the NREMT website at www.nremt.org. Complete a recertification by examination application and pay the \$110 (U.S. funds) exam fee.
- After 24-48 hours, go the NREMT website, login to your account and print your Authorization to Test (ATT) letter. Follow the directions on the letter to schedule your exam.
- Take and pass the exam between October 1 and March 15 (of the year your certification expires.) You will receive an abbreviated recertification application upon successful completion of the exam.
- Return the abbreviated recertification application by March 31 (of the year your certification expires) with signatures and supporting documentation.

All other recertification requirements (including felony statement, CPR/ACLS certification, active affiliation/ practice, verification of skills, Physician Medical Director signature, etc.) must still be met and verified.

You may make one attempt to demonstrate continued cognitive competency by taking an examination (in lieu of documenting continuing education) within six months of your expiration date (October 1 through March 31).

Terms of Recertification

In applying for recertification, registrants agree to comply with all recertification requirements, rules and standards of the NREMT. The registrant bears the burden of demonstrating and maintaining compliance at all times. The NREMT considers individuals to be solely responsible for their certification. Individuals must notify NREMT, within 30 days, of change of mailing address. Change of mailing address can be made via our website: www.nremt.org. Individuals must notify the NREMT, within 30 days, of any felony convictions. Individuals must notify the NREMT, within 30 days, of any disciplinary action taken by any state that has resulted in the following:

- Suspension, revocation, or expiration of state registration/license
- Termination of right to practice
- Voluntary surrender of state registration/license while under investigation

Disciplinary Policy/Revocation of Certification

NREMT has disciplinary procedures, rights of appeals, and due process within its policies. Individuals applying for

certification or recertification who wish to exercise these rights may contact the NREMT for copies of the Disciplinary Procedures. Requests to appeal must be submitted within forty five (45) days of receipt of notice of a determination.

Audits

The National Registry reserves the right to investigate recertification material at any time. You must retain documentation of all continuing education. Failure to submit education when audited will result in denial of eligibility to recertify.
